**At the WBPF Executive Committee meeting held on November 30th, 2016 at the Ambassador City Hotel Jomtien, Pattaya, Thailand, it was unanimously decided to cease working with Golden Times organisation basing on the following circumstances:**

- 1. that your organization does not conduct any Anti-Doping program in your competitions, particularly in the amateur invitational events;**
- 2. that your organization does not have any rules/criteria on judging;**
- 3. that you slandered and humiliated the good image of our WBPF Vice-President for Asia Mr. Amir Bayat from the Islamic Republic of Iran by attacking him and the athletes of Iran as cheats and dishonest people, and not welcoming any Iranian bodybuilders/athletes to the Golden Times competitions in future;**
- 4. it has come to our notice that you are directly in contact with our affiliates from Austria, Ukraine, Mongolia, Belgium and several other members, and bypassed the WBPF Secretariat and our officially recognised member which is the WBPF/ABBF China based in Qingdao, People's Republic of China.**
