ALLEGATION OF ISSUING FORGED CERTIFICATES

Dear Mr. Xin Jian,

It has come to our knowledge and attention that you have been using the signature of Datuk Paul Chua, President of the Asian Bodybuilding and Physique Sports Federation and the seal (stamp) of ABBF in all the Certificates of Coaching and Training issued by you to over 1000 persons and collecting payment of between US\$800.- and US\$1800.- for 7 days and 14 days courses respectively for your own benefit.

Furthermore, ABBF has been informed that you have been telling all your students that these monies which were collected by you was paid to the ABBF.

Under the ABBF Constitution, Article 32 (6) of the 2015 Edition, it is clearly stated that **"The issuing of false amateur certificates shall be deemed a serious violation"**. Forging the signature of anyone and using the ABBF seals without approval for financial gain is a criminal offence under the Law. You may be liable to be prosecuted under Article 32 (6) of the ABBF Constitution to face disciplinary action by my Committee.

You are **hereby required to provide documentary proof** that Datuk Paul Chua or ABBF gave the approval for you to use his name, signature and seal for all the Certificates issued by you and the full list of all those certified under ABBF/China as coaches and personal trainers from Jan 2018 onwards in the People's Republic of China, **within 7 (seven) days** upon receipt of this letter. You are to also cease and desist from issuing any further certifications with the signature of Datuk Paul Chua and the use of our officials seals.

We look forward to your reply within 7 (seven) days upon receipt of this letter, failing which we will call for a Hearing for you to be present at a place and venue to be fixed by us, and if you fail to attend then we will be left without any choice but to act according to the law of the ABBF to take the necessary action against you. Notwithstanding the response, we reserve the right to report this matter to the Chinese Authorities and declaring publicly the issued certificates are fakes. We request for your compliance on this matter.
