NOTICE OF EXPULSION

Dear Mr. Xin Jian,

We refer to the investigations against you for forging the signature of Datuk Paul Chua, the unauthorised use of WBPF and ABBF logos, forging the seal of ABBF and unauthorised use of ABBF member country flags on your ABBF-IFA certification program in China.

The matter was fixed for hearing but prior to the hearing we received the embarrassing news that you were alleged in an assault case against another Chinese supporter Mr Gao who was attending the Championships. The matter was further reported to the Police in Chiang Mai.

As a result, the WBPF Congress on 14 December 2018 heard the matter and unaimously voted that given the gravity of the matters against you, to expel you from the WBPF and ABBF for life.

Notice is hereby given that you, Mr Xin Jian is hereby;

- Expelled for life from WBPF and ABBF,
- That you are prohibited from representing WBPF/ABBF China in any capacity at any of the ABBF and WBPF sanctioned events,
- That you are prohibited from entering any premises demarkated as official hotel and/or official competition venue,
- That all your titles bestowed upon you is hereby stripped and you are not permitted to use your titles, badges, judges license and accoutrements issued to you under WBPF and ABBF,
- And that all your certificates are deemed illegal and a public announcement shall be made to ensure all recipients are told the truth, and
- WBPF and ABBF shall report this matter to the authorities in China through official and diplomatic channels.
